Michael Baumgartner [R-WA-5]	 Private institutions of higher education (IHEs) with total endowments above \$6 billion or with "investments of concern" above \$250 million must report a list of investments in the activities of concern, including their value and the value of capital gains from their sales Investments acquired through an investment company will be treated as owned

H.R.9331: Higher Education Accountability Tax (HEAT) Act	8/9/2024	Rep. David P. Joyce [R-OH- 14]	 Increases the endowment tax on investment income from 1.4 percent to 10 percent Doubles the annual tax on eligible endowments from 10 percent to 20 percent for institutions that raised the "price of attendance above rate of inflation over the preceding three years"² Lowers endowment threshold from \$500,000 per student to \$250,000 for private colleges and universities

Mike Gallagher [R- WI-8]	 Denies organizations a tax exemption if they hold any interest in a "disqualified Chinese company" A disqualified Chinese company is any corporation incorporated in China, or one that invests more than 10 percent of its stock in certain Chinese entities Treasury may grant waivers under specified circumstances Organizations that hold interest in any disqualified Chinese company must file annual reports describing their investments
